Good day Mr. Goldman,

This is to advise that we can confirm your client can travel to the Cayman Islands on the Israeli Provisional Passport you have provided as shown in the PDF document labeled Annex 1.

For your client to travel to the Cayman Islands, the Israeli Provisional Passport can be used for Israeli citizens to enter the Cayman Islands but is subject to them having onward or return tickets.

It is important to note, that the Israeli Provisional passport must also be accepted and allow them entry to jurisdictions on their onward or return route.

With regards to your request to apply for a Business Visa, this would be processed by Workforce Opportunities & Residency Cayman and there is a process for this permit which includes completing an application as well as other required documents. For ease of reference, I have included the link to where you can find the application.
