Dear Mark,

I am pleased to tell you that the Icelandic authorities decided to allow travellers with the Israeli provisional passport to enter the country. This was done on a temporary basis until the required regulatory amendments have been made to recognise the provisional passport on a permanent basis.

Thus, citizens of Israel holding a provisional passport are free to enter Iceland without obtaining a visa, just like holders of a normal passport.
