Dear Mr. Goldman,

I can confirm that holders of valid provisional Israeli passports have the right to visit Liechtenstein under the same conditions as holders of regular passports of the State of Israel. This means in particular they do not require a visa to enter Liechtenstein for short stay visits (max. 90 days in 180 days). Visa provisions for Switzerland and Liechtenstein according to nationality can be found under the following link:
