Kindly see hereunder, response from the Immigration Department further to your query on Israeli provisional passport acceptance for visiting the Republic of Seychelles.

Dear Ms Rose,

By way of response to the message, you may wish to give the re-assurance that Israeli passport holders as well as passport holders of all UN member countries are granted entry permission in Seychelles on the condition that the person:

- **Is not a prohibited immigrant**
- **holds a valid passport (typically one which has at least six months validity)**
- **holds a valid return or onward ticket for the duration of the visit**
- **has confirmed accommodation**
- **has sufficient funds for the duration of the stay**

A Visitor's Permit may be granted for a period of visit of up to three months. It can be extended for successive periods not exceeding three months at a time to a maximum period of twelve months, provided that the person still meets the criteria of a bona fide visitor.

The Visitor's Permit is issued free of charge for the first three months or any part thereof.
